Basic Requirements	<ul style="list-style-type: none"> <li>○ Residents of Iksan City for at least two years (registered residents of Iksan City as of January 2024 to the present)</li> <li>○ Families that have not visited their home country within the past two years</li> <li>※ Includes households that have not benefited from self-funded or other organizations' home country visit support programs</li> <li>○ Those who are not disqualified from overseas travel</li> <li>○ Only applicable to legally married couples</li> </ul>	※ All basic requirements must be met.
Preferential Conditions	<ul style="list-style-type: none"> <li>○ Priority for families that have not previously received support from this program</li> <li>○ Families in financial difficulty</li> <li>○ Families with few visits to their home country</li> <li>○ Families with a long period of residence (marriage)</li> <li>○ Families with many children(Children under 18 years of age)</li> <li>○ Families supporting parents-in-law aged 65 or older, single-parent families or families with a disability</li> </ul>	※ Priority will be given in order of highest score based on evaluation by the Judging Committee.

One copy each of Resident Registration Certificate and Resident Registration Abstract (including address history)</li> <li>5-1. Certificate of Alien Registration (including past residence history) <ul style="list-style-type: none"> <li>* Required if nationality has not been acquired or if less than 2 years have passed since naturalization</li> </ul> </li> <li>6. One copy of Marriage Certificate</li> <li>7. One copy of Detailed Family Relations Certificate</li> <li>8. One copy of Certificate of Entry and Exit Records (for marriage immigrants) <ul style="list-style-type: none"> <li>* Can be issued at local Eup/Myeon/Dong offices or the Immigration Office (4th floor, Iksan Station)</li> <li>* Inquiry period: From the date of first entry into Korea to the present Must submit records both before and after any name change</li> <li>* All entry/exit records to the home country are considered visits to the home country</li> </ul> </li> <li>9. One copy each of Health Insurance Payment Certificate for the marriage immigrant and spouse <ul style="list-style-type: none"> <li>* For the most recent 3 months (Nov. 1, 2025 – Jan. 31, 2026)</li> <li>* If a household member has not paid health insurance premiums, a Qualification Acquisition/Loss Certificate must be attached</li> </ul> </li> <li>10. Certificate of Basic Livelihood Security recipient, low-income family, single-parent family, or disability (if applicable))</li> </ol>
